Assistant or Associate Professor in Process Systems Engineering

The Department of Chemical and Biomedical Engineering at West Virginia University invites applications for tenure-track positions at the rank of Assistant or Associate Professor depending upon qualifications. Candidates must have research expertise in the area of process systems engineering, with emphasis on one of the following areas: mathematical modeling including multi-scale modeling, process intensification, optimization, control, artificial intelligence techniques, and/or other computational approaches especially in the area of energy systems. The new faculty member will complement the already established and strong program in process systems engineering in the department that has more than 30 graduate students and over \$2 million/year in research funding.

Eligible candidates must have a PhD in chemical engineering focused in the area of process systems engineering. Candidates with a BS in Chemical Engineering and a PhD in a closely related engineering discipline and focused in the area of process systems engineering will also be considered. For the rank of Assistant Professor, post-doctoral research experience of at least one year is desired, but outstanding candidates without post-doctoral research experience will also be considered. Candidates for the rank of Associate Professor must have an outstanding record of teaching, research and service. Candidates must also have the ability to (1) teach a variety of courses at both the undergraduate and graduate levels within the Department; (2) develop and sustain an externally funded research program leading to national and international recognition, support and mentor graduate and undergraduate students, postdoctoral fellows and other research personnel, publish peer-reviewed papers, make presentations at national meetings and collaborate within multi-disciplinary teams of faculty and other researchers within the department, college, and university; and (3) perform service activities commensurate with the position and become a collegial faculty member.

West Virginia University is the comprehensive Land Grant University of the State of West Virginia with a main campus enrollment of over 29,000 students, and a Carnegie Classification of Highest Research Activity (R1 University). Morgantown and its vicinity have a population of about 62,000 residents and are ranked among the most livable small cities in the country. The community lies within a high technology corridor that also includes several federal research facilities, such as the U.S. Department of Energy's National Energy Technology Laboratory (DOE/NETL), NASA's Independent Verification and Validation Facility (IV&V), the National Institute of Occupational Safety and Health (NIOSH) and the FBI, as well as private industry. The city is located within reasonable driving distances from Pittsburgh, PA and Washington, DC.
